IT IS HEREBY AGREED AS FOLLOWS:

AMENDMENT NO. 3

It is hereby agreed to amend Contract No. 22-819, as follows:

SECTION F. FISCAL PROVISIONS

Amend Section F, Paragraph 1, to read as follows:

CFS shall commit to the Contractor one dollar (\$1) for every two dollars (\$2) that Contractor invests in and/or contributes to the programs and/or projects described in Section B of this Contract. Upon the initiation of, and at the sole discretion of CFS, one dollar (\$1) to one dollar (\$1) reimbursement may be available on a case by case basis. The maximum amount of reimbursement under this Contract shall not exceed \$1,657,949, which includes an additional \$30,000 for the 2025-26 Fiscal Year, and shall be subject to the availability of funds to the County. The consideration to be paid to Contractor, as provided herein, shall be in full payment for all the Contractor's services and expenses incurred in the performance hereof, including travel and per diem. Reimbursements will be based on the Children's Fund, Incorporated Budget (Attachment C) and shall be made on a monthly basis.

ATTACHMENTS

Amend Attachment C – Budget

Add amended Budget for the Fiscal Year 2025-26 , which is attached to this Amendment No. 3 and incorporated by reference.

All other terms and conditions of Contract No. 22-819 remain in full force and effect.
