## IT IS HEREBY AGREED AS FOLLOWS:

# **AMENDMENT NO. 4:**

It is hereby agreed to amend Contract No. 20-324, as follows:

# 1. REPLACE Section D. TERM OF CONTRACT, with the following:

This Contract is effective as of June 2, 2020 and expires June 30, 2028 but may be terminated earlier in accordance with provisions of this Contract. If at any time, County discontinues use of the Archibus, cadNow/SpaceView and/or Microview software, County shall have the right to immediately terminate this agreement.

### 2. REPLACE Section F. FISCAL PROVISIONS, F.1 with the following:

The maximum amount of payment under this Contract shall not exceed \$1,877,604 (effective 1/1/2026) and shall be subject to availability of other funds to the County. The consideration to be paid to Contractor, as provided herein, shall be in full payment for all Contractor's services and expenses incurred in the performance hereof, including travel and per diem.

Consultant bears the risk that it may not be able to generate its anticipated (or any) profit in completing its performance of all required items of work for the specified level of compensation. In no event shall Consultant be entitled to receive compensation for any item of work required of Consultant under the terms of the Contract, which item of work is not performed by Consultant (including Consultant's agents and approved subcontractors).

## 3. ADD to ATTACHEMENT A - Fee Schedule, the following:

#### Fees and Schedule

The fees for providing these services from January 1, 2026, to June 30, 2028, are provided below. These costs are based on the previous fiscal year average burn rate of approximately \$9,000/month. Subsequent years have a 5% increase to account for increases to Langan's fee schedule. Drawing management numbers are estimated based on current usage, and also have a 5% increase each fiscal year. Please note that the project fees represented in this proposal are substantially discounted from Langan's Standard Schedule of Compensation. Langan remains committed to being budget conscious and in all cases will strive to reduce spend over time. This includes minimizing monthly support to necessary and requested items.

#### Scope of Services

Langan will provide flexible support bounded by the budget and schedule of this agreement, and as directed by SBC leadership. Based on our understanding of SBC's needs and strategic priorities, Langan expects to perform work in some or all the following areas:

  - o Troubleshoot any problems encountered resulting in down or blocked production processes.
  - o Create durable fixes while preserving the integrity of SBC data.
- Improve Application Security. Sample objectives:
  - Set up Single Sign On (SSO) integrated with SBC SSO infrastructure.
  - Clean up inactive user accounts.
- Improve Space Accounting / Chargeback Processes and Data. Sample objectives:
  - Clean up SBC drawings All buildings with occupied space to have an up-to- date drawing.
  - Document SBC space accounting processes; plan and implement needed changes to Archibus.
  - Decide on and implement approach to space history data.
- Simplified UI. Sample objectives:
  - Reduce homepage and application complexity
  - o Improve Power BI dashboards
- Application Performance. Sample objectives:
  - o Continue to perform incremental improvements to identified slow areas
  - Work with ITD to improve overall application performance

#### Fee Schedule

Work will be performed on a time and materials basis according to the rate table below. All services will be performed remotely by Langan staff unless approved by SBC.

Please note that fiscal year 2026 rates remain unchanged from the current rates agreed in Amendment 3 to contract 20-324. Rates in subsequent fiscal periods increase by 5% per fiscal period rounded to the nearest \$5/hour. These rates represent a substantial discount in comparison to Langan's Standard Schedule of Compensation, reflecting Langan's ongoing commitment to the success of this effort.
