IT IS HEREBY AGREED AS FOLLOWS:

AMENDMENT No. 6

Contract No 15-501 to provide law enforcement service in the form of a Deputy Sheriff, acting as a School Resource Officer to the Victor Valley Union High School District is hereby amended, effective July 1, 2021 as follow: (1) by replacing the first sentence of Section V. TERM AND TERMINATION, with the sentence below to change the contract end date from June 30, 2021 to June 30, 2022; (2) to add Section VII.A to allow the use of digital signatures for this Contract and subsequent amendments; and (3) to replace the Schedule A referred to in Sections I.A and II.A with the Schedule A attached hereto and incorporated herein by reference.

V. TERM AND TERMINATION

The term of this contract shall be for a period of time commencing July 1, 2015 through June 30, 2022.

VII. FULL UNDERSTANDING
