AMENDMENT NO. 1 TO AGREEMENT NO. 25-655

The San Bernardino County Fire Protection District (SBCFPD) and Consolidated Fire Agencies Joint Powers Authority (CONFIRE) hereby agree to amend their Temporary Transfer of Vehicular Equipment – Type 2 Ambulance Agreement No. 25-655 (Agreement), for the provision of a Type 2 Ambulance as follows:

1. Section D, TERM, of the Agreement is DELETED and REPLACED with the following:

D. TERM:

1. The term of this Agreement is from August 19, 2025, through August 18, 2027, unless terminated in accordance to the provisions in the Agreement.
2. Either party may, by written notice to the other party, terminate this Agreement at any time and without cause by giving written notice to the other party of such termination, and specifying the effective date thereof, at least thirty (30) days after the date of such notice.
2. All other terms of Agreement shall remain in full force and effect.
3. This Amendment No. 1 may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Agreement.

The parties shall be entitled to sign and transmit an electronic signature of this Agreement (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Agreement upon request.
