# IT IS HEREBY AGREED AS FOLLOWS:

# **AMENDMENT No. 1**

Agreement No. 22-509 with City of Big Bear Lake - Code Compliance Division, to provide dispatch services throughout the geographical boundaries of the County of San Bernardino, is hereby amended, effective June 25, 2024, as follows:

(1) To replace Section C – TERM AND TERMINATION with the following:

### C. TERM AND TERMINATION

The term of this Agreement shall be for a period of three years beginning July 1, 2022 and ending on June 30, 2026. Notwithstanding the foregoing, this Agreement may be terminated at any time with or without cause by CONTRACTOR or by SHERIFF upon written notice given to the other party at least ninety (90) days prior to the date specified for such termination. Any such termination date shall coincide with the end of a calendar month. In the event of such termination, each party shall fully pay and discharge all obligations in favor of the other accruing prior to the date of such termination, and each party shall be released from all obligations or performance which would otherwise accrue subsequent to the date of termination. Neither party shall incur any liability to the other by reason of termination.

(2) To replace Section D – FISCAL PROVISIONS with the following:

### D. FISCAL PROVISIONS

- D.1 CONTRACTOR shall pay SHERIFF the sum of money listed in the CONTRACTOR'S law enforcement services Schedule A. Detail of cost is listed in Attachment I hereto and incorporated herein by reference. SHERIFF shall invoice CONTRACTOR for the cost of services quarterly in arrears, plus overtime, if any. SHERIFF shall submit a quarterly invoice including any overtime generated during the previous quarter for hours of service outside of this Agreement, outlined in the Scope of Services provision. Payment shall be due within forty-five (45) days from the date of each invoice.
- D.2 Attachment I reflects the rates in effect at the Execution of this Agreement. SHERIFF shall have the right to adjust the Agreement rates annually and any subsequent rate change(s) shall become effective on July 1 of the COUNTY fiscal year (July 1 through June 30). Such rate change(s) is affected by the service provided during the prior year and increased labor costs from Memorandum of Understanding changes. SHERIFF shall provide notice to CONTRACTOR of pending rate change(s) by providing CONTRACTOR with a revised Attachment I, which shall be signed by CONTRACTOR and returned to SHERIFF.
- **D.3** If a change in service level is requested or required during the fiscal year, SHERIFF shall provide a revised Attachment I, incorporating such changes, which shall be signed by CONTRACTOR and returned to SHERIFF. CONTRACTOR's subsequent invoice shall be adjusted in accordance with the rate change(s).
- **D.4** COUNTY reserves the right to reduce the level of dispatching services resulting from labor relations actions and CONTRACTOR's obligation to pay COUNTY shall be reduced for services not performed for that reason.
