IT IS HEREBY AGREED AS FOLLOWS:

AMENDMENT NO. 1

This Amendment No. 1 ("Amendment"), effective as of December 16, 2025, is made by and between Forward Advantage Holdings, Inc. ("Contractor") and San Bernardino County ("County") on behalf of Arrowhead Regional Medical Center and modifies the terms of the Contract between the parties to license the Imprivata Single Sign-On Software licenses and service as purchased from Forward Advantage, Inc. fully executed on March 26, 2025 ("Contract"), as follows:

1. Section F.1 of the Contract is deleted in its entirety and replaced with the following:
 - F.1 The maximum amount of payment under this Contract shall not exceed \$692,471 of which \$692,471 may be federally funded, and shall be subject to availability of other funds to the County. The consideration to be paid to Contractor, as provided herein, shall be in full payment for all Contractor's services and expenses incurred in the performance hereof, including travel and per diem.

All other terms and conditions of Contract No. 4400027851 remain in full force and effect.

This Amendment may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Contract. The parties shall

be entitled to sign and transmit an electronic signature of this Amendment (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Amendment upon request.
