

ORDINANCE NO. SD ~~232-041~~ 243-____

An ordinance of San Bernardino County, State of California, acting as the governing body of all board-governed County Service Areas and their Zones to repeal Ordinance No. SD ~~232-041~~ and to adopt fees and charges for Fiscal Year ~~2023-24~~ 2024-25.

The Board of Supervisors of the County of San Bernardino, State of California, acting in its capacity as the governing body of all County Service Areas and their Zones, ordains as follows:

SECTION 1. Effective July 1, 20243, Ordinance No. SD ~~23-2-041~~ is repealed in its entirety.
