**AMENDMENT No. 8**

Contract No. 18-640 to provide law enforcement service in the form of a Deputy Sheriff, acting as a School Resource Officer to the Redlands Unified School District is hereby amended, effective July 1, 2025 as follows: (1) by replacing the first sentence of Section V. TERM and TERMINATION, with the sentence below to change the contract end date from June 30, 2025 to June 30, 2026; and (2) to replace the Schedule A referred to in Sections I.A. and II.A with the Schedule A attached hereto and incorporated herein by this reference.

**V. TERM AND TERMINATION**

The term of this Contract shall be for a period of time commencing July 1, 2025 through June 30, 2026.
