

**RESOLUTION NO. 2026-77**

**RESOLUTION OF THE BOARD OF SUPERVISORS OF SAN BERNARDINO COUNTY, STATE OF CALIFORNIA, ACTING IN ITS CAPACITY AS THE GOVERNING BOARD OF COUNTY SERVICE AREA 70, ZONE R-23 (MILE HIGH PARK), FIXING THE SPECIAL TAX RATE FOR FISCAL YEAR 2026-27**

On Tuesday June 9, 2026, on motion of Supervisor Baca, Jr., duly seconded by Supervisor Hagman and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

SECTION 1. The Board of Supervisors of San Bernardino County, acting in its capacity as the governing board of County Service Area 70, Zone R-23, therefore, hereby finds and determines:

(a) That on January 29, 2002, the electors of County Service Area 70, Zone R-23, duly authorized a special tax levy for road maintenance services.

(b) That the amount of such tax shall not exceed \$240 per improved parcel, per year and \$120 per unimproved parcel, per year.

SECTION 2. The Board of Supervisors of San Bernardino County, acting in its capacity as the governing board of County Service Area 70, Zone R-23, therefore, hereby resolves and orders:

(a) That in order to meet the proposed appropriations, the special tax for Fiscal Year 2026-27 shall be set at \$240 per improved parcel and \$120 per unimproved parcel.

(b) That following the adoption of this resolution, the Clerk of the Board shall cause a copy of same to be published once in a newspaper of general circulation within the district.

(c) That this resolution shall be effective July 1, 2026.

(d) That the Auditor-Controller/Treasurer/Tax Collector is directed to place the direct charge levies on the applicable tax roll.
