RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF SAN BERNARDINO TO ACCEPT GRANT FUNDS FROM THE SOUTHERN CALIFORNIA ASSOCIATION OF GOVERNMENTS FUTURE COMMUNITIES PILOT PROGRAM FOR THE REMOTE ELECTRONIC WARRANTS PROGRAM

On Tuesday February 11, 2020, on motion of Supervisor Lovingood, duly seconded by Supervisor Gonzales and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

WHEREAS, on November 1, 2018, the Southern California Association of Governments (SCAG) approved opening a Call for Applications for the Future Communities Pilot Program (FCPP); and

WHEREAS, among the goals of the program are to “test innovative approaches for reducing emissions-producing Vehicle Miles Traveled from local travel and municipal operations,” and to “improve efficiency and reduce the costs of city and county municipal services,” and that pilot programs should be replicable by other jurisdictions and agencies; and

WHEREAS, on December 13, 2018, the County Chief Executive Officer approved the submission of the grant application through the authority delegated in County Policy 05-13 for the Remote Electronic Warrants Program; and

WHEREAS, on February 7, 2019, the SCAG Regional Council approved the County’s FCPP application for the Remote Electronic Warrants Program and the County will receive a grant award in the amount of \$297,242; and

WHEREAS, this grant requires a minimum 25 percent match, which will be funded in-kind by staff time from the Superior Court of California, County of San Bernardino (Court) and the County of San Bernardino (County) in the amount of \$143,237; and

WHEREAS, the County’s Remote Electronic Warrants Program is made possible by recent legislation (Assembly Bill 2710; Chapter 176, Statutes of 2018), which took effect January 1, 2019 and allows law enforcement officers to seek approval of search and arrest warrants remotely, without having to physically travel to a courthouse; and

WHEREAS, San Bernardino County is geographically the largest county in the contiguous United States and law enforcement officers are often required to travel long distances to a courthouse to obtain search and arrest warrants; and

WHEREAS, the County’s Remote Electronic Warrant Program would build on an already successful program for processing warrants remotely after hours and on weekends; and

WHEREAS, the County Law and Justice Group (L&JG) Administration will manage the grant; the County Information Services Department (ISD) will develop and implement the program, in coordination with primary users of the system to include the Court and the Sheriff/Coroner/Public Administrator; the Court will host the system and review warrant requests; and L&JG Administration will reimburse ISD for their costs related to the grant.

NOW, THEREFORE, BE IT RESOLVED by the San Bernardino County Board of Supervisors as follows:

The Chairman of the Board of Supervisors and/or the Chief Executive Officer are hereby authorized to accept a Southern California Association of Governments Future Communities Pilot Program grant award in the amount \$297,242.
