AMENDMENT NO. 2

Effective as of the date this Amendment is fully executed, the Contract ("Contract") between San Bernardino County and ACCO Engineered Systems, Inc. ("Contractor") with an effective date of June 1, 2021 is amended as follows:

1. Section F.3 of the Contract is deleted in its entirety and replaced with the following:

F.3 The total amount of payments under this Contract for repairs shall not exceed \$3,283,710. Each individual repair project shall not exceed the amount set forth in Public Contract Code Section 20032(a) (currently set at \$75,000) except in the case of a County determined emergency under Public Contract Code Section 22050. The consideration to be paid to Contractor, as provided herein, shall be in full payment for all Contractor's services and expenses incurred in the performance hereof, including travel and per diem.

2. **Full and Effect.** All other terms and conditions of the Contract remain in full force and effect.

3. **Capitalized Terms.** Any capitalized term used but not defined in this Amendment shall have the meaning given to it in the Contract.

4. **Counterparts.** This Amendment may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Amendment. The parties shall be entitled to sign and transmit an electronic signature of this Amendment (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to other party an original signed Amendment upon request.
