1. ITEM NO. 1: LAST DAY TO SUBMIT QUESTIONS

Contractors are advised of the following change as it appears within Section A., Bidding Requirements, Instructions to Bidders of the Specifications:

- A. Contractors are advised that Item 1, Form and Preparation of Bid Proposal and Signature in the Instructions to Bidders section of the bid package issued on December 29, 2025 (as amended) shall be replaced with:

Should any of the questions require changes to the specifications or requirements, an addendum will be issued to clarify those changes. Bidders shall be responsible for ensuring that they have received all addendums issued by the Department and the submittal of a bid shall be deemed to be based on the Bid Documents, as modified and/or clarified by any and all addenda.

Contractors are advised of the following change as it appears within Section A., Bidding Requirements, Instructions to Bidders of the Specifications

- A. Contractors are advised that Item 8, Interpretation of Drawings and Specifications in the Instructions to Bidders section of the bid package issued on December 29, 2025 (as amended) shall be replaced with:

If any bidder is in doubt as to the true meaning of any requirements of drawings or specifications, or finds any discrepancies in, or omissions from the drawings or specifications, the bidder may submit to the engineer a written request for an interpretation or correction

thereof. The written request must be received by **Tuesday, February 3, 2026**. The person making the request will be responsible for its prompt delivery. Interpretations or corrections will be made only by addenda to specifications or by dated revisions or drawings with a copy of each addition or change being furnished through the district to each prospective bidder. Only a written interpretation or correction by Addendum shall be binding.

2. ITEM NO. 2: BID OPENING DATE

Contractors are advised of the following change as it appears within Section A., Bidding Requirements, Instructions to Bidders of the Specifications:

Notice is hereby given that the Department of Public Works – Special Districts (Department), on behalf of the Board of Supervisors for San Bernardino County Service Area 70J-Oak Hills (District), will receive sealed bids for the CSA 70 J RECOATING OF TANKS & PUMP STATIONS PROJECT on or before February 10, 2026 at 2pm at their office at 222 W. Hospitality Lane, 2nd Floor, San Bernardino, California, 92415-0450, at which time the bids will be opened VIRTUALLY VIA GO TO MEETING, Bids received after this time will be returned unopened. Bids shall be valid for 60 calendar days after the bid opening date.

3. BIDDER QUESTIONS

Question 1: Will any items require field painting or coating and if so please identify these items and provide specifications for the required systems?

Answer: No. There are no items requiring field painting or coating.

Question 2: The plans specify Allied-Locke Industries as the clarifier environmental components manufacturer. Allied-Locke Industries has confirmed they are no longer bidding or supporting wastewater projects. Please provide an alternate acceptable manufacturer for the clarifier, or confirm approved equivalent options and any required approval procedures.

Answer: the acceptable alternative manufacturer is Veolia or approved equal, in accordance with the contract documents and substitution procedures.

Question 3: Can you provide us with a list of the contractors that attended the mandatory pre-bid meeting?

Answer: Please see the attached mandatory Pre-Bid sign-in sheet.

Question 4: Is ePro a free service for public works bids as several of our agencies use this platform.

Answer: Yes, ePro is a free service.
