Effective August 13, 2024, Contract No. 22-733 is hereby amended as follows:

**SECTION III. TERM** is amended to read as follows:

This Contract shall be effective August 13, 2022, and is extended from its expiration date of August 12, 2024, to expire on August 12, 2025, subject to the termination provisions below. Notwithstanding the foregoing, either party may terminate this Contract at any time, without cause, with a fourteen (14) day prior written notice to the other party. This Contract may be terminated for just cause immediately by the County. Contractor shall serve at the pleasure of the appointing authority, who shall have the full authority and discretion to exercise County rights under this paragraph.

All other terms and conditions of Contract No. 22-733 remain unchanged and are incorporated herein by this reference.
