AMENDMENT NO. 3

San Bernardino County ("County") and STERIS ("Steris") agree to amend the terms of the Agreement ("Agreement") fully executed on June 2, 2020 by and between Medivators and County of San Bernardino, as previously amended, as follows, effective as of the date this Amendment is fully executed:

- 1. For the period of October 1, 2023 through September 30, 2025, the equipment (Serial # 78147431 and Serial # 78147437, collectively, "Equipment") in the Agreement shall receive the Cantel Platinum-Advantage Plus service with each equipment receiving two preventative maintenance inspections and two filter changes annually as set forth in Attachment A-2 to this Amendment.
- 2. The fees for the services under the Agreement for the Equipment from October 1, 2023 through September 30, 2025 shall be in accordance with Attachment A-2 to this Amendment.
- 3. The term of the Agreement is extended such that the end date shall be September 30, 2025.
- 4. The following language is added to the Agreement:

Political Contributions

Standard Contract Page 1 of 6

Steris has disclosed to the County using Attachment A-1, whether it has made any campaign contributions of more than \$250 to any member of the County Board of Supervisors since January 1, 2023. Steris acknowledges that under Government Code section 84308, Steris is prohibited from making campaign contributions of more than \$250 to any member of the County Board of Supervisors or County elected officer for 12 months after the County's consideration of Amendment No. 3 of the Agreement.

In the event of any amendment to this Agreement, Steris will provide the County a written statement disclosing any campaign contribution(s) of more than \$250 to any member of the County Board of Supervisors or other County elected officer within the preceding 12 months of the date of the proposed amendment.

Campaign contributions include those made by any agent/person/entity on behalf of the Steris or by a parent, subsidiary or otherwise related business entity of Steris.

- 5. This Amendment and all attachments may be signed in one or more counterparts, each of which shall be deemed an original but all of which taken together shall constitute one and the same instrument. The parties shall be entitled to sign and transmit an electronic signature of this Amendment and al attachments (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Amendment upon request.
- 6. All other terms and conditions of the Agreement shall remain in full force and effect.

Attachment A-1 Senate Bill 1439 Contractor Information Report

DEFINITIONS

Actively supporting the matter: (a) Communicate directly, either in person or in writing, with a member of the Board of Supervisors or other County elected officer [Sheriff, Assessor-Recorder-Clerk, District Attorney, Auditor-Controller/Treasurer/Tax Collector] with the purpose of influencing the decision on the matter; or (b) testifies or makes an oral statement before the County in a proceeding on the matter; or (c) communicates with County employees, for the purpose of influencing the County's decision on the matter; or (d) when the person/company's agent lobbies in person, testifies in person or otherwise communicates with the Board or County employees for purposes of influencing the County's decision in a matter.

Agent: A third-party individual or firm who is representing a party or a participant in the matter submitted to the Board of Supervisors. If an agent is an employee or member of a third-party law, architectural, engineering or consulting firm, or a similar entity, both the entity and the individual are considered agents.

Otherwise related entity: An otherwise related entity is any for-profit organization/company which does not have a parent-subsidiary relationship but meets one of the following criteria:

- (1) One business entity has a controlling ownership interest in the other business entity;
- (2) there is shared management and control between the entities; or
- (3) a controlling owner (50% or greater interest as a shareholder or as a general partner) in one entity also is a controlling owner in the other entity.

For purposes of (2), "shared management and control" can be found when the same person or substantially the same persons own and manage the two entities; there are common or commingled funds or assets; the business entities share the use of the same offices or employees, or otherwise share activities, resources or personnel on a regular basis; or there is otherwise a regular and close working relationship between the entities.

<u>Parent-Subsidiary Relationship:</u> A parent-subsidiary relationship exists when one corporation has more than 50 percent of the voting power of another corporation.
