RESOLUTION NO. 2024-23

RESOLUTION OF THE BOARD OF SUPERVISORS OF SAN BERNARDINO COUNTY, STATE OF CALIFORNIA, ACTING IN ITS CAPACITY AS THE GOVERNING BODY OF COUNTY SERVICE AREA 70, ZONE R-21 (MOUNTAIN VIEW), AUTHORIZING A MAILED BALLOT ELECTION FOR PROPERTY OWNERS TO ESTABLISH AN INCREASED PROPERTY RELATED SERVICE CHARGE FOR A CAPITAL IMPROVEMENT PROJECT FOR ROAD PAVING PROJECT

On Tuesday February 27, 2024, on motion of Supervisor Baca, Jr., duly seconded by Supervisor Hagman and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

SECTION 1. The Board of Supervisors of the County of San Bernardino, acting in its capacity as the governing body of County Service Area 70, Zone R-21 (Mountain View), hereby finds and determines:

- a) That County Service Area 70 Zone R-21 (Mountain View) was formed in 1987 for the purpose and reasons of providing road paving, maintenance, and snow removal services for approximately 1,290 feet of roadway in the unincorporated area of San Bernardino County.
- b) That this Board desires to establish an increase to the property related service charge, pursuant to Proposition 218 and Article XIII D, Section 6 of the California Constitution, in the Big Bear City area (CSA 70, R-21 Mountain View), from \$90.00 per parcel, as initially set in 1987, to \$804.62 per parcel per year, for ten years, effective Fiscal Year 2024-25, for a Capital Improvement Project (CIP) to repave Mountain View Boulevard and provide for ongoing operation and maintenance costs to provide road paving, maintenance, and snow removal services.
- c) That the exterior boundaries of the said zone are described and set forth in Exhibit "A," attached hereto and incorporated herein by this reference.
- d) Written notice of the proposed increased property related service charge was provided on December 15, 2023, by mail, to the record owner of each identified parcel upon which the increased fee or charge is proposed for imposition, the amount of the fee or charge proposed to be imposed upon each, the basis upon which the amount of the proposed fee or charge was calculated, the reason for the fee or charge, together with the date, time, and location of a public hearing on the proposed fee or charge.
- e) A public hearing was conducted on February 27, 2024, in which the Board considered all protests against the proposed increased property related service charge and to determine if written protests against the proposed fee or charge are presented by a majority of owners of the identified parcels.
- f) At the conclusion of the public hearing, it was determined that no majority protest exists regarding the proposed property related fee or charge.
- g) Proposition 218 requires any new property related service charge to be submitted for voter approval by a majority vote of the property owners of the property subject to the increased fee or charge. The election for such increased property related service charge shall be conducted not less than 45 days after the public hearing.
- h) That this Board desires to authorize a mailed ballot election of property owners to establish said service charge revision with a proposed FY 2024-25 service charge of

\$804.62 per parcel to fund a CIP to repave Mountain View Boulevard and provide for ongoing operation and maintenance costs to provide road paving, maintenance, and snow removal services.

SECTION 2. The Board of Supervisors of San Bernardino County, acting in its capacity as the governing body of County Service Area 70, therefore, hereby resolves and orders:

- a) That this Board herby authorizes an election, pursuant to Proposition 218 and Article XIII D, Section 6 of the California Constitution, to propose an increased property related service charge of \$804.62 per parcel effective Fiscal Year 2024-25, for ten years, and upon California State Board of Equalization approval, to fund a Capital Improvement Project (CIP) to repave to repave Mountain View Boulevard and provide for ongoing operation and maintenance costs to provide road paving, maintenance, and snow removal services.
- b) That this Board authorizes an election to be voted on by property owners within CSA 70, R-21 through a mailed ballot election conducted by an independent election service provider.
- c) That the election date for the proposed ballot is April 12, 2024, or any day thereafter.
- d) That the Auditor-Controller/Treasurer/Tax Collector place the service charge of \$804.62 on the next property tax roll if the election is successful.
