IT IS HEREBY AGREED AS FOLLOWS:

AMENDMENT NO. 2

This Amendment No. 2 (this "Amendment"), entered into the date fully executed, is made by and between Ultimate Kronos Systems, LLC ("UKG") and San Bernardino County ("County") on behalf of Arrowhead Regional Medical Center and modifies the terms of the agreement ("Contract") executed between Kronos Incorporated and the County as of July 29, 2020, as previously amended on December 6, 2022, as follows:

- The first recital (WHEREAS) clause of the Contract is deleted in its entirety and replaced with the following:
 WHEREAS, the County conducted a competitive process to find a contractor to provide a time and attendance management system; and
- 2. All references to "County of San Bernardino" in the Contract are amended to read as "San Bernardino County".
- 3. All references to "Kronos Incorporated" in the Contract are amended to read as "UKG Kronos Systems, LLC".
- 4. Section F.1 of the Contract is deleted in its entirety and replaced with the following:
 - F.1 The maximum amount of payment under this Contract shall not exceed Three Million One Hundred Seventy Eight Thousand Seven Hundred and Ninety Nine Dollars (US \$3,178,799). The consideration to be paid to Contract, as provided herein, shall be in full payment for all Contractor's services and expenses incurred in the performance hereof, excluding travel and per diem.

- 5. Add Attachment A-3, Quote No. 225092, as attached hereto and incorporated herein.
- 6. Full Force and Effect. All other terms and condition of the Contract remain in full force and effect.
- 7. **Capitalized Terms.** Any capitalized term used but not defined in this Amendment shall have the meaning given to it in the Contract.
- 8. UKG has disclosed to County using County's Campaign Contribution Disclosure Senate Bill 1439 form, attached hereto as Schedule 1, whether it has made any campaign contributions of more than \$250 to any member of the San Bernardino County Board of Supervisors or San Bernardino County elected officer (e.g., Sheriff, Assessor-Recorder-Clerk, Auditor-Controller/Treasurer/Tax Collector and the District Attorney) within the 12 months before the date this Amendment was approved by the San Bernardino County Board of Supervisors. UKG acknowledges that under Government Code section 84308, UKG is prohibited from making campaign contributions of more than \$250 to any member of the San Bernardino County Board of Supervisors or San Bernardino County elected officer for 12 months after the County's consideration of the Amendment. In the event of a further proposed amendment to the Agreement, UKG will provide County a written statement disclosing any campaign contribution(s) of more than \$250 to any member of the San Bernardino County Board of Supervisors or other San Bernardino County elected officer within the preceding 12 months of the date of the proposed amendment. Campaign contributions include those made by any agent/person/entity on behalf of the UKG or by a parent, subsidiary or otherwise related business entity of UKG.
- 9. Counterparts. This Amendment (including Quote No. 225092_ may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same document. The parties shall be entitled to sign and transmit an electronic signature of this Amendment (whether by facsimile, PDF or other email transmission), including Quote No. 225092, which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Amendment upon request.

SCHEDULE 1 Campaign Contribution Disclosure (SB 1439)

DEFINITIONS

Actively supporting the matter: (a) Communicate directly with a member of the Board of Supervisors or other County elected officer [Sheriff, Assessor-Recorder-Clerk, District Attorney, Auditor-Controller/Treasurer/Tax Collector] for the purpose of influencing the decision on the matter; or (b) testifies or makes an oral statement before the County in a proceeding on the matter for the purpose of influencing the County's decision on the matter; or (c) communicates with County employees, for the purpose of influencing the County's decision on the matter; or (d) when the person/company's agent lobbies in person, testifies in person or otherwise communicates with the Board or County employees for purposes of influencing the County's decision in a matter.

<u>Agent:</u> A third-party individual or firm who, for compensation, is representing a party or a participant in the matter submitted to the Board of Supervisors. If an agent is an employee or member of a third-party law, architectural, engineering or consulting firm, or a similar entity, both the entity and the individual are considered agents.

Otherwise related entity: An otherwise related entity is any for-profit organization/company which does not have a parent-subsidiary relationship but meets one of the following criteria:

- (1) One business entity has a controlling ownership interest in the other business entity;
- (2) there is shared management and control between the entities; or
- (3) a controlling owner (50% or greater interest as a shareholder or as a general partner) in one entity also is a controlling owner in the other entity.

For purposes of (2), "shared management and control" can be found when the same person or substantially the same persons own and manage the two entities; there are common or commingled funds or assets; the business entities share the use of the same offices or employees, or otherwise share activities, resources or personnel on a regular basis; or there is otherwise a regular and close working relationship between the entities.

Parent-Subsidiary Relationship: A parent-subsidiary relationship exists when one corporation has more than 50 percent of the voting power of another corporation.
