IT IS HEREBY AGREED AS FOLLOWS:

AMENDMENT NO. 1

WHEREAS, San Bernardino County on behalf of Arrowhead Regional Medical Center ("Customer") and MediWaste Disposal, LLC ("MediWaste") entered into an agreement for the provision of medical waste, hazardous, pharmaceutical and e-waste management disposal services ("Agreement") with an effective date of May 19, 2026; and

WHEREAS, the parties desire to amend the Agreement to add an additional service location to the Agreement; and

NOW THEREFORE, effective as August 4, 2026, the Agreement is amended as follows:

1. The following service location is added to Attachment A of the Agreement – Scope of Service, Section 14 – Locations:
