



## FIRST AMENDMENT TO MULTIPLE PRODUCT PURCHASE AGREEMENT

This First Amendment (“Amendment”) effective as of the date of last signature is, by and between Integra LifeSciences Sales LLC (“Integra”) and San Bernardino County, on behalf of Arrowhead Regional Medical Center (“County”).

WHEREAS, Integra and County are parties to that certain Multiple Product Purchase Agreement, dated January 14, 2025 (“Agreement”), for the purchase of the Products under the terms of the Agreement; and

WHEREAS, Integra and County have agreed to amend the Agreement through this Amendment.

NOW, THEREFORE, for good and valuable consideration, and intending to be legally bound hereby, Integra and County agree as follows:

1. Addition of Schedule 4. The attached Schedule 4 is hereby incorporated into this Agreement for the purpose of adding Acclarent Products to the Agreement.
2. Update Schedule References. Any reference within the Agreement to “Schedule 2” shall hereby add “Schedule 4.” All terms and conditions applicable to Schedule 2 shall apply equally to Schedule 4 (Acclarent Products), unless expressly stated otherwise.
3. For the avoidance of any doubt, the price increases in Schedule 3 do not apply to any of the Products identified in Schedule 4.

All other provisions of the Agreement shall remain in full force and effect. All terms not defined herein shall have the meaning ascribed to them in the Agreement. This Amendment may be executed in counterparts, each of which shall be deemed an original but all of which shall constitute one and the same instrument, which may be executed and delivered by facsimile or electronic transmission.
