AMENDMENT NO. 16

Contract No. 07-262 is hereby amended, effective March 24, 2022 as follows:

(1) Section 3 – Term, is hereby replaced with the following:

3. Term: The term of this CONTRACT shall commence on the Effective Date and shall continue through March 23, 2023, or until terminated in accordance with its terms.

(2) Exhibit 2 of the CONTRACT is hereby replaced with the attached Exhibit 2, which is incorporated herein by reference.

All other terms and conditions of the CONTRACT remain in full force and effect.

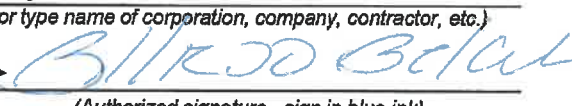

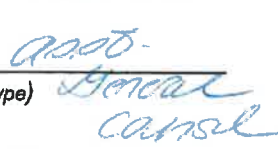

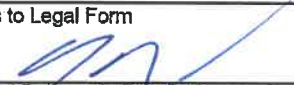
