

**RESOLUTION NO. 2023-65**

**ADOPT RESOLUTION THAT RATIFIES SAN BERNARDINO COUNTY FIRE PROTECTION DISTRICT ORDINANCE NO. FPD 23-01, REPEALING SAN BERNARDINO COUNTY FIRE PROTECTION DISTRICT ORDINANCE NO. FPD 20-01 AND ADOPTING THE SAN BERNARDINO COUNTY FIRE PROTECTION DISTRICT FIRE CODE, WHICH ADOPTS BY REFERENCE THE 2022 EDITION OF THE CALIFORNIA FIRE CODE, ALONG WITH CERTAIN CHANGES, MODIFICATIONS, AMENDMENTS, ADDITIONS, DELETIONS, AND EXCEPTIONS TO THE 2022 EDITION OF THE CALIFORNIA FIRE CODE, RELATING TO FIRE REGULATIONS**

On Tuesday, May 23, 2023, on motion of Supervisor Baca Jr., duly seconded by Supervisor Hagman and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County.

WHEREAS, on February 28, 2023 (Item No. 79), the Board of Directors of the San Bernardino County Fire Protection District adopted Ordinance No. FPD 23-01. A copy of San Bernardino County Fire Protection District Ordinance No. FPD 23-01 is attached to this resolution and incorporated by reference.

WHEREAS, the San Bernardino County Fire Protection District adopted findings in Ordinance No. FPD 23-01, which set forth that the adoption of the Ordinance is reasonably necessary because of local climatic, geological, and topographical conditions. The findings were adopted in accordance with Health and Safety Code section 13869.7.

WHEREAS, in accordance with Health and Safety Code section 13869.7, the Board of Supervisors may ratify, modify or deny the San Bernardino County Fire Protection District Ordinance No. FPD 23-01.

WHEREAS, upon ratification of Ordinance No. FPD 23-01, the County shall submit within 15 days a copy of this resolution and San Bernardino County Fire Protection District Ordinance No. FPD 23-01 with the findings set forth in Ordinance No. FPD 23-01, to the California Department of Housing and Community Development.

NOW, THEREFORE, IT IS HEREBY RESOLVED by the Board of Supervisors:

1. The above recitals are true and correct.
2. The San Bernardino County Fire Protection District Ordinance No. FPD 23-01 is ratified.
