SD 25-___ 2 An ordinance of San Bernardino County, State of California, acting as the governing body of all Board-Governed County 3 Service Areas and their Zones amending Ordinance No. SD 4 25-03 to correct the annual service charge for road maintenance for CSA 70, Zone R-12 Baldwin Lake. 5 6 WHEREAS, on April 8, 2025 (Item No. 68), the Board of Supervisors adopted 7 Ordinance No. SD 25-03, establishing fees and charges for Fiscal Year 2025-26 for all 8 Board-governed County Service Areas and their Zones; WHEREAS, Ordinance No. SD 25-03 set an annual service charge for road 10 maintenance for parcels in CSA 70, Zone R-12 Baldwin Lake; 11 WHEREAS, due to an inadvertent error, Ordinance No. SD 25-03 incorrectly listed 12 the annual service charge for road maintenance for CSA 70, Zone R-12 Baldwin Lake as 13 \$38.23 per parcel instead of the correct intended amount of \$438.23 per parcel; and 14 WHEREAS, it is necessary to correct Section 3, subsection (a)(10), of Ordinance 15 No. SD 25-03 to reflect the accurate annual service charge; 16 **NOW, THEREFORE**, the Board of Supervisors of the County of San Bernardino, 17 State of California, ordains as follows: 18 SECTION 1. Effective October 23, 2025, Section 3, subsection (a)(10) of 19 Ordinance No. SD 25-03, is amended to read as follows: 20 3. Roads. 21 (a) Service Charges for Road Maintenance: These service charges are collected 22 annually on the tax roll at the same time and in the same manner as general ad 23 valorem property taxes: 24 * * * 25 (10) CSA 70, Zone R-12 Baldwin Lake for road maintenance... \$438.23/parcel. 26
