Amendment No. 3 to Agreement No. 19-545

Pursuant to Section 7(c) of Agreement No. 19-545 (Agreement) between the San Bernardino International Airport Authority (SBIAA) and the San Bernardino County Fire Protection District (SBCFPD), SBIAA and SBCFPD agree to amend the Agreement as follows:

Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Amendment No. 3 upon request.
