IT IS HEREBY AGREED AS FOLLOWS:

Amendment No. 2

It is hereby agreed to amend Contract No. 24-286, effective upon execution by all parties, as follows:

SECTION III COMPENSATION

Paragraph A. is amended to read as follows:

- A. The maximum amount of payment for the entire term of this Contract shall not exceed \$288,475.50. Both the TOWN and the County recognize and agree that the not-to-exceed amount of \$288,475.50 takes into account all of the costs identified herein, including a two percent (2%) annual increase to pesticide, vehicle, and other supply and equipment costs, and an anticipated two percent (2%) increase to salaries based on negotiated labor agreements. If services provided by the County exceed the Fiscal Year amount (determined by the County using the County Fee Schedule in effect at the time of service) prior to June 30 of each year, the County shall advise the TOWN of this finding prior to expending the entire amount. The County will not provide any further services, unless and until, the "not-to-exceed" amount is amended and approved by both parties per section VII "Amendments." Thereafter, the TOWN and the County shall negotiate in good faith an amendment to this Contract.

Paragraph C. is amended to read as follows:

- C. County will invoice The TOWN thirty (30) days after each semiannual service period has ended on June 30th and December 31st during each contract year, for the following amounts:

The parties shall be entitled to sign and transmit an electronic signature of this Amendment (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Amendment upon request.
