Amendment No. 1 to Contract for Permit Inspection and Plan Review Services

RECOMMENDATION(S)

Approve **Amendment No. 1**, effective August 13, 2020, to the following contracts, for the provision of on-call Building and Safety permit inspection and plan review services, exercising the one-year option to extend, and increasing the aggregate not-to-exceed total by \$1,750,000, from \$3,500,000 to \$5,250,000, for the total contract period of August 13, 2018, through August 12, 2021:

COUNTY AND CHIEF EXECUTIVE OFFICER GOALS & OBJECTIVES

Improve County Government Operations.

Operate in a Fiscally-Responsible and Business-Like Manner.

Ensure Development of a Well-Planned, Balanced, and Sustainable County.

FINANCIAL IMPACT

Approval of this Amendment will not result in the use of additional Discretionary General Funding (Net County Cost). This Amendment increases the contract aggregate not-to-exceed total by \$1,750,000, from \$3,500,000 to \$5,250,000. Sufficient appropriation and revenue is included in the Land Use Services Building and Safety Division (BNS) 2020-21 budget and will be included in future recommended budgets.

BACKGROUND INFORMATION

BNS is responsible for the enforcement of Building Standards adopted by the County and the State of California. The division utilizes on-call professional service providers on an as-needed basis to support BNS staff in maintaining consistent and uninterrupted services during times of high workloads and staff turnovers. These on-call professionals allow BNS to ensure building

code compliance to protect the public's health, safety and welfare in the County's unincorporated areas.

On August 7, 2018 (Item No. 15), the Board of Supervisors (Board) approved the following contracts, for the provision of on-call BNS permit inspection and plan review services, with an aggregate total not to exceed \$3,500,000, for the period of August 13, 2018, through August 12, 2020, with a one-year option to extend:

2. Bureau Veritas North America, Inc. Contract No. 18-565
3. CSG Consultants, Inc. Contract No. 18-566

The proposed Amendment exercises the one-year option to extend the existing contracts for the total contract period of August 13, 2018, through August 12, 2021, and increases the aggregate not-to-exceed total from \$3,500,000 to \$5,250,000.

PROCUREMENT

As a result of a successful competitive procurement process, the Board approved the existing contracts on August 7, 2018 for two years with a one-year option to extend the term, for an aggregate not-to-exceed total of \$3,500,000. Approval of this item allows BNS to continue utilizing these contractors on an as-needed basis to provide permit inspection and plan review services.


