IT IS HEREBY AGREED AS FOLLOWS:

**AMENDMENT NO. 2
CONTRACT NO. 21-418**

WHEREAS, on June 8, 2021, San Bernardino County (COUNTY) and EXP U.S. Services, Inc. (CONSULTANT) entered into County Contract No. 21-418 ("the CONTRACT"), in the amount of \$3,503,005.93, for professional engineering services and environmental services for Project Approval/Environmental Document (PA/ED) Phase I of the Phelan Road Widening Project in the Phelan Area, hereinafter called "the PROJECT"; and

WHEREAS, on May 9, 2023 (Item No. 42), the Board approved Amendment No. 1 to Contract No. 21-418, extending the Contract's expiration date from June 8, 2023 to December 19, 2025, to complete professional engineering services and environmental services for Project Approval/Environmental Document (PA/ED) with no change in the contract amount; and

WHEREAS, the CONSULTANT is preparing the Project Approval/Environmental Document, and

WHEREAS, COUNTY and CONSULTANT have determined that an extension to the CONTRACT term is necessary and will allow the CONSULTANT to complete preliminary engineering studies, environmental studies, and draft environmental document; and

WHEREAS, COUNTY and CONSULTANT have also determined that additional time is required to complete Project Approval/Environmental Document; and

WHEREAS, COUNTY and CONSULTANT have also determined that an additional update is needed to the agreement representative contact information; and

NOW, THEREFORE, in reference to the aforementioned, the parties agree to amend Contract No. 21-418 as follows:

1. DELETE Section D, "Term of Contract," and REPLACE it with a new Section D, which shall now read as follows:

D. Term of Contract.

The term of the CONTRACT shall commence on June 8, 2021, and shall remain in effect through December 17, 2027, as reflected in the revised Exhibit "C", attached and incorporated herein by this reference.

2. DELETE Section B.3 and REPLACE it with a new Section B.3, which shall now read as follows:

B.3 The Agreement representative/Project Manager and alternate are listed below. Consultant Agreement representative and alternate shall be available locally Monday through Friday and available by cell phone 24 hours a day, Monday through Sunday, including holidays. Consultant or designee must respond to County inquiries within two (2) business days. Consultant will also designate a back-up point of contact in the event the primary contact is not available. This Agreement Representative shall provide overall management and coordination of the Agreement on Consultant's behalf. Any changes to Consultant's Agreement Representative shall be provided to County in writing and shall be subject to the approval of the County's Director of the Department of Public Works:

3. DELETE Section E.1 and REPLACE it with a new Section E.1, which shall now read as follows

6. This Amendment No. 2 to the CONTRACT may be executed by the Parties electronically and in counterparts, all of which together shall constitute a single agreement.
7. This Amendment No. 2 to the CONTRACT shall take effect on the date it is signed and approved by authorized officers of both COUNTY and CONSULTANT.
