**RESOLUTION OF THE BOARD OF SUPERVISORS
OF SAN BERNARDINO COUNTY TO
ESTABLISH “NO COMMERCIAL PARKING / TOW AWAY ZONE” OF COMMERCIAL VEHICLES
HAVING A GROSS WEIGHT RATING EXCEEDING 10,000 POUNDS ON FONTANA AVENUE
IN THE FONTANA AREA**

On Tuesday, January 27, 2026, on motion of Supervisor Hagman, duly seconded by Supervisor Baca, Jr., and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

WHEREAS, the San Bernardino County Department of Public Works completed a traffic engineering investigation regarding the parking of commercial vehicles on the west side of Fontana Avenue from San Bernardino Avenue approximately 0.53 miles to Carob Avenue in the Fontana Area; and,

WHEREAS, the Board of Supervisors is authorized to establish parking restrictions on County roads pursuant to County Code Section 52.0128(a); and 52.0132(a) and,

WHEREAS, the Board of Supervisors desires, based upon a traffic engineering investigation, to establish parking restrictions for commercial vehicles having a gross weight rating exceeding 10,000 pounds along Fontana Avenue, a residential district street, within the Fontana area.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of San Bernardino County as follows:

1. Due to conditions affecting the welfare of the public utilizing Fontana Avenue in the Fontana area, the Board of Supervisors, pursuant to a traffic engineering investigation, hereby finds and determines it necessary to:
 - a. Establish a “No Commercial Parking Zone/Tow Away Zone” of commercial vehicles having a manufacturer’s gross vehicle weight rating exceeding 10,000 pounds on the west side of Fontana Avenue (358500) from San Bernardino Avenue (725400) to Carob Avenue (213600) pursuant to County Code 52.0128(a), 52.0132(a), and 83.11.100(a)(1).
2. The County Road Commissioner is hereby directed to place appropriate signs specifying applicable prohibitions on such streets and to perform such acts as are necessary to establish the parking restrictions above and implement the terms of this resolution.
