IT IS HEREBY AGREED AS FOLLOWS:

Amendment No. 2

This Amendment No. 2 ("Amendment") is made by and between Vicom Infinity, Inc. ("Vicom") and San Bernardino County ("County") effective as of June 23, 2026, and modifies the terms of Contract No. 23-1392 executed between the parties as of December 19, 2023 ("Contract").

1. Amend Section D. Term of Contract to read as follows:

D. TERM OF CONTRACT.

This contract is effective as of December 19, 2023, and expires December 18, 2027, with one (1) additional one (1) year extension option, but may be terminated earlier in accordance with the provisions of this Contract. All Executed Work Orders executed during the term of this Contract will be governed by the terms of this Contract, regardless of the expiration date of the Executed Work Order.

2. **Full Force and Effect.** The Contract, as amended by this Amendment, remains in full force and effect.
3. **Capitalized Terms.** Any capitalized term used but not defined in this Amendment shall have the meaning given to it in the Contract.

4. **Counterparts.** This Amendment may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same agreement. The parties shall be entitled to sign and transmit an electronic signature of this Amendment (whether by facsimile, PDF, or other email transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Amendment upon request.
