- 1. DELETE paragraph F.1 in Section F., "FISCAL PROVISIONS", and REPLACE it with a revised paragraph F.1., which shall now read as follows:
 - F.1 The maximum amount of payment under this Contract shall not exceed \$7,500,000 and shall be subject to availability of other funds to the County. The consideration to be paid to Contractor, as provided herein, shall be in full payment for all Contractor's services and expenses incurred in the performance hereof, including travel and per diem.
- 2. All other terms and conditions of Agreement No. 23-86 shall remain unchanged.
- 3. This Amendment No. 3 shall take effect on the date it is last signed by both parties.
- 4. This Amendment may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Amendment.
