Amendment No. 1

**WITNESSETH:**

IN THAT CERTAIN: Contract No. 19-0151 by and between the County of San Bernardino ("County") and Embassy Consulting Services, LLC ("Contractor") for training courses, which first became effective April 1, 2019, the following changes are hereby made and agreed effective October 27, 2020:

**I. SECTION F. FISCAL PROVISIONS**, Paragraph F.1 is hereby amended to read as follows:

The maximum amount of payment under this Contract shall not exceed \$120,000, of which \$120,000 may be federally funded, and shall be subject to availability of other funds to the County. The consideration to be paid to Contractor, as provided herein, shall be in full payment for all Contractor's services and expenses incurred in the performance hereof, including travel and per diem.

**II. SECTION L. ELECTRONIC SIGNATURE** is hereby added to read as follows:

This Contract may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Contract. The Parties shall be entitled to sign and transmit an electronic signature of this Contract (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose name is contained therein.

Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Contract upon request.

III. All other terms, conditions, and covenants in Contract No. 19-0151 remain in full force and effect.
