IT IS HEREBY AGREED AS FOLLOWS:

WHEREAS, San Bernardino County ("COUNTY"), as landlord, and Burr Group Inc. ("LICENSEE"), entered into License Agreement, Contract No. 16-504 dated June 28, 2016, as amended on May 18, 2021 (the "First Extended Term"), (Collectively, "the License") wherein COUNTY agreed to license certain premises of approximately 21,780 square feet of land located within the COUNTY's Crestline Yard in Crestline, as more specifically set forth in the License, (Assessor Parcel No. 0344-061-11) in Crestline, CA; and

WHEREAS, the COUNTY and LICENSEE desire to extend the License for five (5) years starting July 1, 2026 and expiring June 30, 2031, to serve a public health, social and financial purpose.

NOW, THEREFORE, in consideration of the mutual covenants and conditions, the parties hereto agree that the License is amended as follows:

- 1. Effective July 1, 2026, DELETE in its entirety the existing **Paragraph 2, TERM**, and substitute therefore the following as a new **Paragraph 2, TERM**:
 - 2. <u>TERM:</u> The term of this License shall be extended five (5) years, from July 1, 2026 through June 30, 2031 (the "Second Extended Term").

2. Effective July 1, 2026, DELETE in its entirety the existing **Paragraph 4, LICENSE FEES**, and SUBSTITUTE therefore the following as a new **Paragraph 4, LICENSEE FEES**:

4. **LICENSE FEES**:

A. The LICENSEE agrees to pay the COUNTY the License fee of One Thousand One Hundred Dollars (\$1,100.00) per month, which license fee shall increase annually on the anniversary of the commencement date of this License by three percent (3%), rounded up or down to the nearly whole dollar, over the license fee paid for the immediately prior year as more specifically set forth below. All fees are due in advance on the first day of each month, commencing when the Initial Term commences, continuing during the Initial Term. The license fees for the Initial Term are as follows:

July 1, 2026 through June 30, 2027 – monthly fee payments of \$1,100.00 July 1, 2027 through June 30, 2028 – monthly fee payments of \$1,133.00 July 1, 2028 through June 30, 2029 – monthly fee payments of \$1,167.00 July 1, 2029 through June 30, 2030 – monthly fee payments of \$1,202.00 July 1, 2030 through June 30, 2031 – monthly fee payments of \$1,238.00

- B. If any License fee or other sums under this License is not paid when due and payable, LICENSEE shall pay to COUNTY an additional Twenty-Five and 00/100 Dollars (\$25.00) for each overdue License Fee or other sums as an administrative processing charge. The parties agree that this administrative charge represents a fair and reasonable estimate of the costs that COUNTY will incur by reason of late payment by LICENSEE. Acceptance of any administrative charge shall not constitute a waiver of LICENSEE's default with respect to the overdue License fee or other sums or prevent COUNTY from exercising any of the other rights and remedies available to COUNTY.
- 3. Effective as of the date this Amendment is fully executed by the Parties, ADD in its entirety **Paragraph**44, LEVINE ACT CAMPAIGN CONTRIBUTION DISCLOSURE and EXHIBIT "4", Levine Act Campaign
 Contribution Disclosure incorporated and attached herein, which new **Paragraph** 44 shall read as follows:
 - 44. **LEVINE ACT CAMPAIGN CONTRIBUTION DISCLOSURE**: LICENSEE has disclosed to the County using "Exhibit 4" LEVINE ACT CAMPAIGN CONTRIBUTION DISCLOSURE, whether it has made any campaign contributions of more than \$500 to any member of the Board of Supervisors or other County elected officer [Sheriff, Assessor-Recorder-Clerk, Auditor-Controller/Treasurer/Tax Collector and the District Attorney] within the earlier of: (1) the date of the submission of Landlord's proposal to the County, or (2) 12 months before the date this License was approved by the Board of Supervisors. LICENSEE acknowledges that under Government Code section 84308, LICENSEE is prohibited from making campaign contributions of more than \$500 to any member of the Board of Supervisors or other County elected officer for 12 months after the County's consideration of the License.

In the event of a proposed amendment to this License, the LICENSEE will provide the County a written statement disclosing any campaign contribution(s) of more than \$500 to any member of the

Board of Supervisors or other County elected officer within the preceding 12 months of the date of the proposed amendment.

Campaign contributions include those made by any agent/person/entity on behalf of the LICENSEE or by a parent, subsidiary, or otherwise related business entity of LICENSEE.

4. This Second Amendment may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Second Amendment. The parties shall be entitled to sign and transmit an electronic signature of this Second Amendment (whether by facsimile, PDF, or other email transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Second Amendment upon request.

Levine Act – Campaign Contribution Disclosure

(formerly referred to as Senate Bill 1439)

The following is a list of items that are not covered by the Levine Act. A Campaign Contribution Disclosure Form will not be required for the following:

- Contracts that are competitively bid and awarded as required by law or County policy
- Contracts with labor unions regarding employee salaries and benefits
- Personal employment contracts
- Contracts under \$50,000
- Contracts where no party receives financial compensation
- Contracts between two or more public agencies
- The review or renewal of development agreements unless there is a material modification or amendment to the agreement
- The review or renewal of competitively bid contracts unless there is a material modification or amendment to the agreement that is worth more than 10% of the value of the contract or \$50,000, whichever is less
- Any modification or amendment to a matter listed above, except for competitively bid contracts.

DEFINITIONS

Actively supporting or opposing the matter: (a) Communicate directly with a member of the Board of Supervisors or other County elected officer [Sheriff, Assessor-Recorder-Clerk, District Attorney, Auditor-Controller/Treasurer/Tax Collector] for the purpose of influencing the decision on the matter; or (b) testifies or makes an oral statement before the County in a proceeding on the matter for the purpose of influencing the County's decision on the matter; or (c) communicates with County employees, for the purpose of influencing the County's decision on the matter; or (d) when the person/company's agent lobbies in person, testifies in person or otherwise communicates with the Board or County employees for purposes of influencing the County's decision in a matter.

<u>Agent:</u> A third-party individual or firm who, for compensation, is representing a party or a participant in the matter submitted to the Board of Supervisors. If an agent is an employee or member of a third-party law, architectural, engineering or consulting firm, or a similar entity, both the entity and the individual are considered agents.

Otherwise related entity: An otherwise related entity is any for-profit organization/company which does not have a parent-subsidiary relationship but meets one of the following criteria:

- (1) One business entity has a controlling ownership interest in the other business entity;
- (2) there is shared management and control between the entities; or
- (3) a controlling owner (50% or greater interest as a shareholder or as a general partner) in one entity also is a controlling owner in the other entity.

For purposes of (2), "shared management and control" can be found when the same person or substantially the same persons own and manage the two entities; there are common or commingled funds or assets; the business entities share the use of the same offices or employees, or otherwise share activities, resources or personnel on a regular basis; or there is otherwise a regular and close working relationship between the entities.

<u>Parent-Subsidiary Relationship:</u> A parent-subsidiary relationship exists when one corporation has more than 50 percent of the voting power of another corporation.
