IN THAT CERTAIN **Contract No. 22-471** by and between San Bernardino County, a political subdivision of the State of California, and High Desert Child, Adolescent and Family Services Center, Inc. for Early Intervention Outpatient Treatment, Intensive Outpatient Treatment and Recovery Services, which Contract first became effective July 1, 2022, the following changes are hereby made and agreed to:

- I. ARTICLE V <u>FUNDING</u>, paragraphs K and L, are hereby amended to read as follows:

 - L. The revised Schedules A and B for fiscal years 2022-23 and 2023-24 will be submitted to, and approved by, the Director or designee at a later date. All previously approved schedules remain in effect.

II. All other terms, conditions and covenants in the basic agreement remain in full force and effect.
