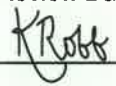

Item No. 33 from June 10, 2025, grants delegated authority to the Auditor-Controller/Treasurer/Tax Collector (ATC) as described in recommendation No. 2. ATC is approving an amendment provided by SAP for 25 additional SAP Analytics Cloud non-prod licenses at \$33,781.25, using the remaining contract credit of \$495,366. The original contract included only 25 non-prod user licenses, which are insufficient for support and training as work continues on the SAP S/4HANA Rise Private cloud project going live in January 2026.
