AMENDMENT NO. 6

This Amendment No. 6 (this "Amendment") dated January 27, 2026 is made by and between Hyland Software, Inc. ("Contractor" or "Hyland"), and San Bernardino County on behalf of Arrowhead Regional Medical Center ("County" or "Customer") and modifies the terms to agreement executed between the parties as of March 2, 2021 ("Contract"), as previously amended on March 15, 2022, May 23, 2023, July 11, 2023, January 14, 2025, and September 9, 2025.

1. Delete Section D. in its entirety and replace with the following:

D. TERM OF CONTRACT

This Contract is effective as of March 2, 2021 and expires February 28, 2027 but may be terminated earlier in accordance with provisions of this Contract.

2. Delete Section F.1 in its entirety and replace with the following:

F.1 The maximum amount of payment under this Contract shall not exceed \$2,698,667.05 of which \$0.00 may be federally funded, and shall be subject to availability of other funds to the County. The consideration to be paid to Contractor, as provided herein, shall be in full payment for all

Contractor's services and expenses incurred in the performance hereof, including travel and per diem.

3. Incorporate Quote, Hyland Reference Number: HYL034150, as attached hereto, into the Contract as though fully set forth therein.
4. **Levine Act - Campaign Contribution Disclosure (formerly referred to as Senate Bill 1439)**
Contractor will comply, and will ensure its agents (as that term is defined under California Government Code section 84308(h)) and its subcontractors identified in Contractor's proposal responding to a County solicitation and/or identified in this Agreement ("Subcontractors") comply, with California Government Code section 84308, the Levine Act - Campaign Contribution Disclosure (formerly referred to as Senate Bill 1439), concerning whether it has made any campaign contributions of more than \$500 to any member of the Board of Supervisors or other County elected officer [Sheriff, Assessor-Recorder-Clerk, Auditor-Controller/Treasurer/Tax Collector and the District Attorney] within the earlier of: (1) the date of the submission of Contractor's proposal to the County, or (2) 12 months before the date this Contract was approved by the Board of Supervisors. Contractor acknowledges that under Government Code section 84308, Contractor is prohibited from making campaign contributions of more than \$500 to any member of the Board of Supervisors or other County elected officer for 12 months after the County's consideration of the Contract. Contractor agrees to submit any disclosures required to be made under the Levine Act at the Office of the Clerk of the Board of Supervisors website at <https://www.sccgov.org/levineact>, and Contractor shall require Subcontractors to do the same. In the event of a proposed amendment to this Contract, the Contractor will provide the County a written statement disclosing any campaign contribution(s) of more than \$500 to any member of the Board of Supervisors or other County elected officer within the preceding 12 months of the date of the proposed amendment. Campaign contributions include those made by any agent/person/entity on behalf of the Contractor or by a parent, subsidiary or otherwise related business entity of Contractor.
5. **Full Force and Effect.** The Contract, as amended by this Amendment, remains in full force and effect.
6. **Capitalized Terms.** Any capitalized term used but not defined in this Amendment shall have the meaning given to it in the Contract or the Addendum, as applicable.
7. **Counterparts.** This Amendment may be executed in any number of counterparts, each of which shall be deemed an original, and such counterparts shall together constitute one and the same Contract. The parties shall be entitled to sign and transmit an electronic signature of this Amendment (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Amendment upon request.
