


PETITION FOR THE ANNEXATION

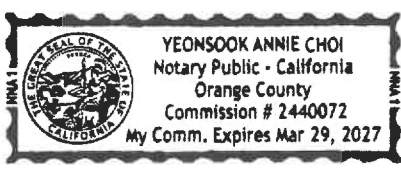

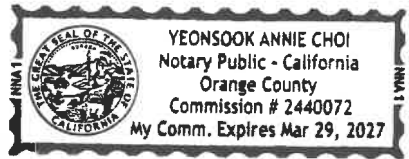
