Contractors need only to attend one (1) of the two (2) Mandatory Pre-Bid Meeting.

Replace the Advertisement for Bid section, pages AB-1 and AB-2 of the bid packaged issued on August 26, 2024 and replace it with the revised Advertisement for Bid section, pages AB-1 and AB-2 hereby issued on September 5, 2024, accompanying this Addendum No. 1.

- B. Contractors are advised that a second Mandatory Pre-Bid Meeting in the Advertisement for Bids section has been added, to take place on Tuesday, September 10<sup>th</sup>, 2024 at 10:00 AM.

Contractors need only to attend one (1) of the two (2) Mandatory Pre-Bid Meeting.

Replace the Instruction to Bidders section, page IB-1 of the bid packaged issued on August 26, 2024 and replace it with the revised Instruction to Bidders section, page IB-1 hereby issued on September 5, 2024, accompanying this Addendum No. 1.

- C. Contractors are advised that a second Mandatory Pre-Bid Meeting in the Advertisement for Bids section has been added, to take place on Tuesday, September 10<sup>th</sup>, 2024 at 10:00 AM.

Contractors need only to attend one (1) of the two (2) Mandatory Pre-Bid Meeting.

Replace the Bid Proposal section, page BP-1 of the bid packaged issued on August 26, 2024 and replace it with the revised Bid Proposal section, BP-1 hereby issued on September 5, 2024, accompanying this Addendum No. 1.

2. BIDDER QUESTIONS

Below are questions and answers submitted as of submission of this addendum:

**Question 1:** Is there a location where the dredging material can be hauled off too?

**Answer:** Once the dredged material has been dried, it can be hauled off to a location called Camp Switzerland. Camp Switzerland is located northeast of Lake Gregory. Refer to the attached map accompanying this Addendum No. 1 for the location and access road route.

**Question 2:** Is the water removal of the swim area part of the scope of work.

**Answer:** In order to execute the work within the Swim Beach and Waterpark Area the contractor is responsible to install temporary cofferdam structures or other means to segregate the Swim Beach and Waterpark Area to execute the grading and other work in this area. The contractor is responsible to dewater the existing water from this area to the other side of the cofferdam structure or other means to expose the area to execute the work. During the dewatering the contractor is responsible to save all fish and wildlife. Contractor is responsible to continuously maintain dewatering activities to execute the work throughout the project. Contractor is responsible to provide a by-pass and diversion means throughout the project and the proposed plan must be submitted for review and approval by the County and agencies within Phase 1.

The above items modify the informal bid documents in the manner prescribed and in that manner only. All other contract items will remain as originally intended. Contractor will sign/date this addendum and submit with their bid as acknowledgement of receiving and complying with this addendum.
