

**RESOLUTION NO. 2021-93**

**RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF SAN BERNARDINO, STATE OF CALIFORNIA, ACTING IN ITS CAPACITY AS THE GOVERNING BODY OF THE NAMED COUNTY SERVICE AREAS AND ZONES, ESTABLISHING STAND-BY AND AVAILABILITY FEES FOR WATER AND SEWER SERVICES AND REPEALING RESOLUTION NO. 2020-88**

On Tuesday, June 8, 2021, on motion of Supervisor Rutherford, duly seconded by Supervisor Baca and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California, acting in its capacity as the governing body of named County Service Areas and Zones.

SECTION 1. The Board of Supervisors of the County of San Bernardino, acting in its capacity as the governing body of the above-named County Service Areas and Zones, hereby finds and determines:

- (a) That this Board has heretofore undertaken proceedings set forth in the former Government Code section 25210.77b at the time the water and sewer standby charges were established in the above-named County Service Areas and Zones.
- (b) That this Board intends to continue to collect the same charges without change from prior year.

SECTION 2. The Board of Supervisors of the County of San Bernardino, acting in its capacity as the governing body of the named County Service Areas and Zones, therefore, hereby resolves and orders:

- (a) That, in accordance with Government Code Section 25215.6(b), there are hereby fixed and continued without change the following amounts:
  - (1) County Service Area 42 sewer standby or availability charges for each parcel of real property therein in the amount of ten dollars (\$10.00) per full acre in a parcel, plus ten dollars (\$10.00) for any portion of a parcel which may exceed an exact number of acres;
  - (2) County Service Area 70, Zone J, water standby or availability charges for each parcel of real property therein in the amount of twenty (\$20.00) dollars per full acre in a parcel, plus the proportionate share of the charge of ten dollars (\$10.00) for any portion of a parcel which may exceed an exact number of acres.
  - (3) County Service Area 53, Zone B (sewer), the charges shall be twenty dollars (\$20.00) per full acre in a parcel; and
  - (4) County Service Areas 42 (water), 64 (water and sewer), 79 (sewer), and County Service Area 70, Zones F (water), S-3 (sewer), W-3 (water), and W-4 (water), the charges shall be thirty dollars (\$30.00) per full acre in a parcel.

- (b) That for parcels of less than one (1) acre total, the charges continued herein for County Service Area 42 (sewer) shall be ten dollars (\$10.00); for County Service Area 70, Zone J (water) and County Service Area 53, Zone B (sewer) the charges shall be twenty dollars (\$20.00); and for County Service Areas 42 (water), 64 (water and sewer), 79, and County Service Area 70, Zones F (water), S-3 (sewer), W-3 (water), and W-4 (water), the charges shall be thirty dollars (\$30.00).
- (c) That water availability or standby charges shall apply to each parcel of real property within the respective county service areas or zones which is within six hundred sixty (660) feet of a water main from which water service is furnished by said county service area or zone.
- (d) That the sewer availability or standby charges shall apply to each parcel of real property within the respective county service areas or zones which is within two hundred (200) feet of a sewer main from which sewer service is furnished by said county service areas or zones.
- (e) That the charges fixed and established herein shall be effective on and after July 1, 2021, and shall be operative during Fiscal Year 2021-22.
- (f) That Resolution No. 2020-88 is hereby repealed in its entirety upon the effective date of this resolution.
