Operate in a Fiscally-Responsible and Business-Like Manner.

FINANCIAL IMPACT

Approval of this item will not impact Discretionary County Funding (Net County Cost) as the recommended amendment is non-financial in nature.

BACKGROUND INFORMATION

On October 1, 2023, Randstad North America, Inc. dba Spherion Staffing, LLC (Randstad) purchased Temp Unlimited, LLC (Temp Unlimited). Randstad formally notified the County of the change on November 9, 2023 and submitted a new Federal Tax Identification Number to the Auditor-Controller/Treasurer/Tax Collector. The recommended Amendments No. 1 will transfer all contractual responsibilities under Contract No. 21-803 and Contract No. 23-143 from Temp Unlimited to Randstad .

PROCUREMENT

Following a competitive process, on October 26, 2021 (Item No. 55), the Board of Supervisors (Board) approved contracts with 12 vendors, including Temp Unlimited Contract No. 21-803 to provide temporary help services to the Registrar of Voters for election workers, with a term of October 26, 2021 through October 25, 2026.

On February 28, 2023 (Item No. 57), the Board approved contracts with 31 vendors, including Temp Unlimited Contract No. 23-143 to provide temporary help services to various County departments at fixed rates, with a term of March 1, 2023 through February 28, 2028.


