## InDesign Server Additional Terms of Use

Last Updated January 20, 2019

These Additional Terms govern your use of InDesign Server and are incorporated by reference into the Adobe General Terms of Use ("General Terms") located at <a href="www.adobe.com/go/terms">www.adobe.com/go/terms</a> (these Additional Terms and the General Terms are collectively referred to as "Terms"). Other Additional Terms incorporated by reference into the General Terms may also govern your use of the Services and Software. Capitalized terms not defined here have the same meaning as defined in the General Terms.

## 1. Additional Definitions.

- 1.1 "Computer" means a virtual or physical device for storing or processing data, such as servers, desktop computers, laptops, mobile devices, Internet-connected devices, and hardware products. Where a device contains more than one virtual environment (including virtual machines and virtual processors), each virtual environment will be counted as a separate Computer.
- 1.2 "Development License" means a license that is restricted to non-production use for testing or staging and is for use with automated publishing solutions made accessible to customers or users via the internet or corporate wide within an Intranet.
- 1.3 "Intranet" means a private, proprietary computer network accessible by you and your authorized employees and contractors. Intranet does not include portions of the Internet, network communities open to suppliers, vendors, or service providers, or network communities open to the public (such as membership or subscription-driven groups, associations, and similar organizations)
- 1.4 "Limited License" means an internal facing, automated or semi-automated publishing solution for use within a company network.
- 1.5 "On-premise Software" means the Adobe software that is deployed by or on behalf of you on hardware designated by you.
- 1.6 "Premium License" means for use with automated publishing solutions made accessible to customers or users other than your employees via the internet in addition to rights to use corporate wide within an Intranet.
- 1.7 "User" means an individual (either an employee or temporary worker of yours) who may use or access the Services and Software.
- 2. Limited License. If you have obtained a Limited License for the On-premise Software then you may install and use the On-premise Software only for the purpose of (a) permitting Users connected to your Intranet to download the On-premise Software for installation or (b) permitting Users to use the On-premise Software through the use of commands, data, or instructions from a Computer connected to the your Intranet, provided that the total number (not the concurrent number) of Users that use the On-premise Software does not exceed the number of Users licensed under this Agreement.
