



Addendum to Order Form-Q-02178378

1. Effect of Addendum. The Order Form, the underlying Thomson Reuters General Terms and Conditions, and applicable Schedule A (collectively the "Agreement"), between you and West is amended to incorporate the terms of this Addendum. As amended, the Agreement will remain in full force and effect according to its terms and conditions. All terms used in this Addendum will have the meanings given to them in the Agreement. This Addendum supersedes all prior understandings and agreements, oral or written, relating to the subject matter. If there is a conflict between the terms and conditions of the Agreement and the terms and conditions of this Addendum, the terms and conditions of this Addendum will control.

2. Modification of General Terms and Conditions. The following changes to the terms and conditions are set forth below:

2.1 The first sentence in Section 2(e), Limited License to Your Data is amended to state the following:

“You hereby grant us a revocable non-exclusive license and right to use, copy, store, host, display, transmit and process Your Data solely as necessary for Thomson Reuters, our employees and contractors to provide our Services under the Agreement and in accordance with applicable law.”

2.2 The following language is added to Section 6, Confidentiality as set forth below:

“or (e) is required to be disclosed by law.”

2.3 The following language is deleted from Section 8(b), Unlimited Liability

“Section 8(a) does not limit your indemnification obligations in Section 8(d)”

2.4 Section 8(d), Your Obligations is deleted in its entirety.

2.5 Section 9(a), Term is amended to state the following:

“The term and any renewal terms for the Services are described in the applicable Ordering Document.”

3. Modification to Agreement.

The following provision is added to the Agreement:

(a) ELECTRONIC SIGNATURES.

This Agreement may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Agreement. The parties shall be entitled to sign and transmit an electronic signature of this Agreement (whether by facsimile, PDF or other mail transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Agreement upon request.

All other terms and conditions of the Agreement will remain unchanged.
