

RESOLUTION NO. 2026-34

CONSTRUCTION FEE SCHEDULES FOR FISCAL YEARS 2026-27, 2027-28, AND 2028-29

On Tuesday, April 7, 2026, on motion of Supervisor Baca, Jr., duly seconded by Supervisor Hagman and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

WHEREAS, on March 24, 2026, the Board of Supervisors conducted a noticed public hearing on the proposed annual County Fee Ordinance and the Construction Fee Schedules for Fiscal Years 2026-27, 2027-28, and 2028-29, containing necessary revisions to the fees; approved introduction of the County Fee Ordinance, scheduled the County Fee Ordinance for final adoption on Tuesday, April 7, 2026; considered the Construction Fee Schedules for Fiscal Years 2026-27, 2027-28, and 2028-29; and directed staff to return to the Board of Supervisors to adopt a resolution that adopts the Construction Fee Schedules for Fiscal Years 2026-27, 2027-28, and 2028-29 on Tuesday, April 7, 2026; and

WHEREAS, Section 8 of the above cited County Fee Ordinance amends the fees in County Code section 16.0204 for the Land Use Services Department - Building Inspection and Plan Review - Building and Safety for Fiscal Years 2026-27, 2027-28, and 2028-29; and

WHEREAS, some of these fees in Section 8 of the above-cited County Fee Ordinance, which amends the fees in County Code section 16.0204 for the Land Use Services Department - Building Inspection and Plan Review - Building and Safety, are based on Construction Fee Schedules for Fiscal Years 2026-27, 2027-28, and 2028-29; and

WHEREAS, Section 8 of the above-cited County Fee Ordinance, which amends the fees in County Code section 16.0204 for the Land Use Services Department - Building Inspection and Plan Review - Building and Safety, states that the Board of Supervisors will adopt the Construction Fee Schedule by resolution; and

WHEREAS, this resolution will adopt the Construction Fee Schedules for fiscal years 2026-27, 2027-28, and 2028-29 which are attached to this Resolution and incorporated into the Resolution by this reference.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Supervisors of San Bernardino County, State of California that:

Section 1. The above recitals are true and correct and are a substantive part of this Resolution and are incorporated herein by this reference.

Section 2. The Construction Fee Schedules for fiscal years 2026-27, 2027-28, and 2028-29 are adopted.
