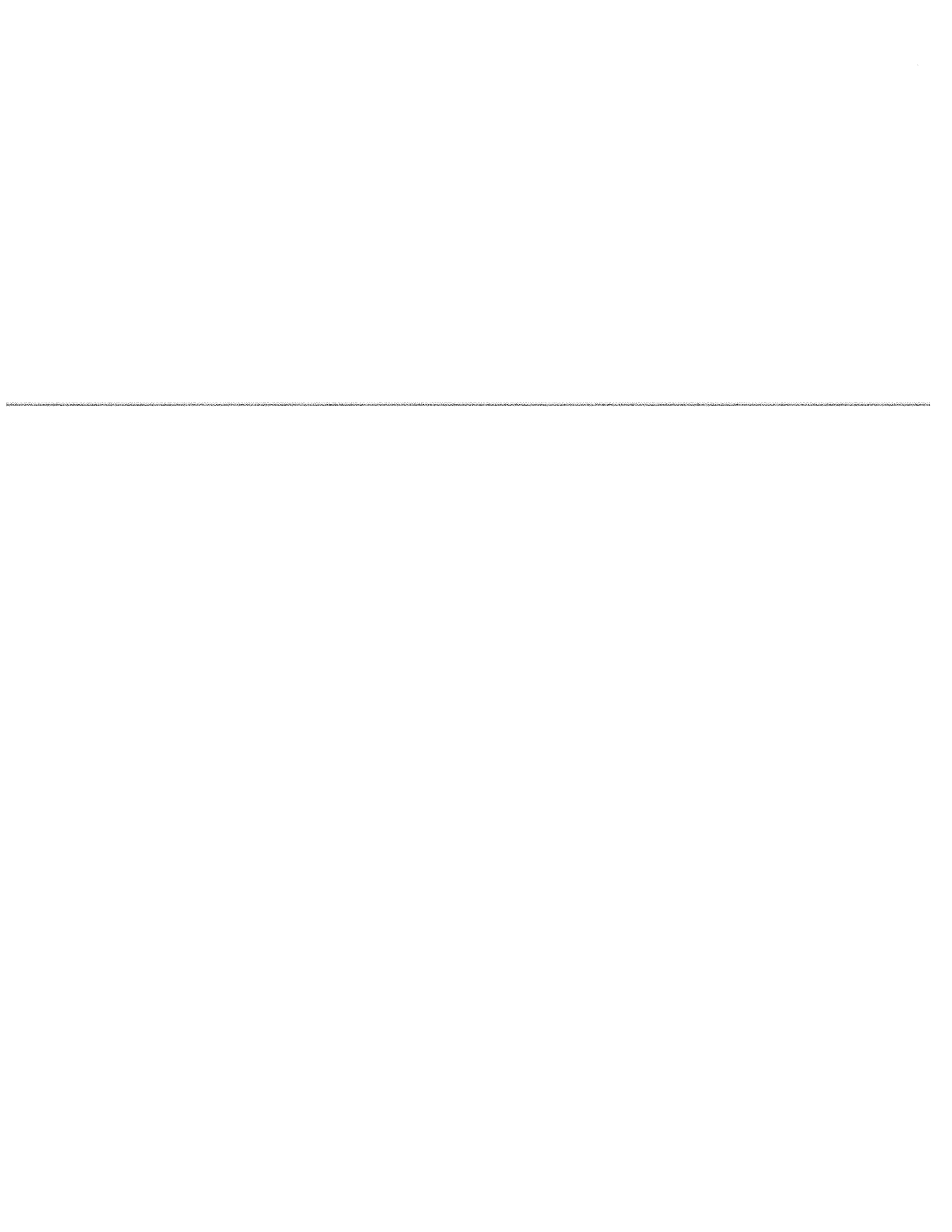

**AMENDMENT NO. 4 TO THE
MEMORANDUM OF UNDERSTANDING
BETWEEN
SAN BERNADINO COUNTY DEPARTMENT OF BEHAVIORAL HEALTH
AND
SUPERIOR COURT OF CALIFORNIA, COUNTY OF SAN BERNARDINO
FOR
DRUG COURT SERVICES**

THE MEMORANDUM OF UNDERSTANDING, which became effective April 1, 2020, between the SAN BERNARDINO COUNTY DEPARTMENT OF BEHAVIORAL HEALTH, herein referred to as DBH, and the SUPERIOR COURT OF CALIFORNIA, COUNTY OF SAN BERNARDINO, herein referred to as Superior Court, to provide substance use disorder services to Drug Court probationers and defendants is hereby amended effective upon execution:

- I. ARTICLE XI – TERM is hereby amended to read as follows:
This Memorandum of Understanding (MOU) is effective as of April 1, 2020 and extends to June 30, 2025. but may be terminated earlier under the provisions of the EARLY TERMINATION section.
- II. ARTICLE IX – FISCAL PROVISIONS, paragraph A is hereby amended to read as follows:
 - A. The maximum amount of reimbursement under this MOU shall not exceed a total contract amount of \$995,927 and shall be subject to availability of funds to DBH. The consideration to be paid to Superior Court, as provided herein, shall be in full payment for all Superior Court's services and expenses incurred in the performance thereof.
- III. This amendment hereby adds Attachment A Budget Schedule for FY 2024-25.
- IV. All other terms and conditions of the MOU remain the same.

This agreement may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Agreement. The parties shall be entitled to sign and transmit an electronic signature of this Agreement (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Agreement upon request.
