## **RESOLUTION NO. 2023-167**

RESOLUTION OF THE BOARD OF SUPERVISORS FOR THE APPROVAL OF THE PUBLIC AUTHORITY/NON-PROFIT CONSORTIUM RATE CHANGE REQUEST TO THE CALIFORNIA DEPARTMENT OF SOCIAL SERVICES FOR IN-HOME SUPPORTIVE SERVICES PROVIDER WAGES

On Tuesday, September 12, 2023, on motion of Supervisor Baca, Jr., duly seconded by Supervisor Hagman and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

WHEREAS, the In-Home Supportive Services (IHSS) Public Authority was established by the San Bernardino County through Ordinance No. 3842 to act as the employer for San Bernardino IHSS providers pursuant to Welfare and Institutions Code section 12301.6, subdivision (c)(1), and to perform other IHSS functions as required by Welfare and Institutions Code section 12301.6, subdivision (e), and not retained by the County; and

WHEREAS, representatives of the San Bernardino County IHSS Public Authority, under direction of the IHSS Public Authority Board of Directors, met and conferred with representatives of the Service Employees International Union Local 2015, and reached a labor agreement under a new Memorandum of Understanding covering wages, hours, and other terms and conditions of employment for employees in the IHSS Provider Unit through June 30, 2026; and

WHEREAS, the California Department of Social Services requires the San Bernardino County, Board of Supervisors to approve IHSS Public Authority/Non-Profit Consortium Rate Change Request (SOC 449), updating the Rate Table pertaining to the IHSS provider wage to align with the new IHSS Provider Unit Memorandum of Understanding, for a total increase of \$1.10 per hour, effective upon approval by the California Department of Social Services, as specified below:

- a. Hourly wage (locally negotiated) increase of \$1.00 per hour, from \$16.00 per hour to \$17.00 per hour.
- b. Health Benefits rate (locally negotiated) increase to up to \$0.42 per hour.
- c. Payroll Tax rate increase of \$0.08, from \$1.32 per hour to \$1.40 per hour.
- d. Administrative Rate decrease of \$0.02 from \$0.08 to \$0.06 per hour.

NOW, THEREFORE BE IT RESOLVED, San Bernardino County, Board of Supervisors' Chairman and Vice Chair affirms the full Board's approval of IHSS Public Authority's Public Authority/Non-Profit Consortium Rate Change Request (SOC 449) to be effective upon approval by the California Department of Social Services, as signed below:
