BACKGROUND INFORMATION

Pursuant to Health and Safety Code section 13869.7, on May 23, 2023 (Item No. 109), the Board of Supervisors (Board) took various actions for San Bernardino County to ratify San Bernardino County Fire Protection District Ordinance No. FPD 23-01 that repeals San Bernardino County Fire Protection District Ordinance No. FPD 20-01 and adopts the San Bernardino County Fire Protection District Fire Code, which adopts by reference the 2022 Edition of the California Fire Code, along with certain changes, modifications, amendments, additions, deletions, and exceptions to the 2022 Edition of the California Fire Code, relating to fire regulations. In addition, the Board considered and approved the introduction of a proposed ordinance that repeals Chapter 1 of Division 3 of Title 2 of the San Bernardino County Code, relating to the Uniform Fire Code. This item is for adoption of that ordinance.
