Amendment to Revenue Contract with Live Nation Worldwide, Inc. for the Provision of Supplemental Law Enforcement Services

**RECOMMENDATION(S)**

Approve **Amendment No. 14 to Revenue Contract No. 14-110** with Live Nation Worldwide, Inc. to update hourly rates for the provision of supplemental law enforcement services on a fee-for-service basis for events held at various county locations, with no change to the contract term of March 1, 2014 through June 30, 2026.

**Operate in a Fiscally-Responsible and Business-Like Manner.**

**Provide for the Safety, Health and Social Service Needs of County Residents.**

**FINANCIAL IMPACT**

Approval of this item will not result in the use of Discretionary General Funding (Net County Cost). Actual revenue received under this contract is contingent on the level of service provided. The new hourly service rates, effective December 16, 2025 as reflected in the contract's Schedule A, recover both direct and indirect costs associated with providing service. The Sheriff/Coroner/Public Administrator's (Department) 2025-26 budget includes sufficient appropriation and revenue for public gathering events.

**BACKGROUND INFORMATION**

The Department contracts with Live Nation Worldwide, Inc. (Live Nation) to provide supplemental law enforcement services for its events (i.e., concerts and electronic dance music festivals) held at the Glen Helen Regional Park Amphitheater. The services provided are performed and priced on an overtime basis and do not impact the Department's regular patrol functions. The contract is amended annually to update the hourly service rates. The overtime rates per safety position include indirect overhead costs, which recover the cost of support staff providing services to Live Nation.

On February 25, 2014 (Item No. 52), the Board of Supervisors (Board) approved Revenue Contract No. 14-110 (Contract) with Live Nation for the period of March 1, 2014 through June 30, 2017. Subsequently, the Board has approved amendments to the Contract, with the most recent being Amendment No. 13 on June 18, 2025 (Item No. 88), to adjust the hourly rates and extend the Contract through June 30, 2026. On September 9, 2025 (Item No. 36), the Board approved a new Memorandum of Understanding between San Bernardino County and the

Sheriff's Employees' Benefit Association (SEBA) for employees in the Safety and Safety Management and Supervisory units. The new memorandum provides for increases to salary and benefits of SEBA-represented employees, effective October 4, 2025. The proposed amendment with the Live Nation amends the hourly rates, and updates language to current standard terms, with no changes to the Contract's term. The Contract can be terminated by either party upon 90 days' advance written notice.


