**AMENDMENT NO. 1**

It is hereby agreed to amend Contract No. 17-822, effective October 28, 2020, as follows:

**SECTION VIII. TERM is amended to read as follows:**

This MOU is effective as of November 1, 2017 and is extended from its amended expiration date of October 31, 2020, to expire October 31, 2022, but may be terminated earlier in accordance with provisions of Section IX. of this MOU.

**SECTION XI. CONCLUSION**

Amend Paragraph B to read as follows:

- B. This MOU may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same MOU. The parties shall be entitled to sign and transmit an electronic signature of this MOU (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an

original signed MOU upon request.

Amend Paragraph C to read as follows:


