THIS CONTRACT is entered into in the State of California by and between San Bernardino County, hereinafter called the County, and Valley Star Behavioral Health, Inc. referenced above, hereinafter called Contractor.

IT IS HEREBY AGREED AS FOLLOWS:

WITNESSETH:

IN THAT CERTAIN **Contract No. 17-710** by and between San Bernardino County, a political subdivision of the State of California, and Contractor for Crisis Residential Treatment program services, which Contract first became effective September 1, 2017, the following changes are hereby made and agreed to, effective March 1, 2022:

- I. ADDENDUM I, Section XIII, Facility Location paragraph F is hereby amended to read as follows:
 - F. County shall provide on-site security guard(s) during the day and night, 24 hours a day, 7 days a week. Coverage will be specific to industry standards for treatment programs, which shall include providing building security as deemed suitable by the County.

II. All other terms, conditions and covenants in the basic agreement remain in full force and effect.

This Agreement may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Agreement. The parties shall be entitled to sign and transmit an electronic signature of this Agreement (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Agreement upon request.

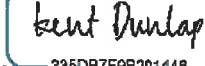

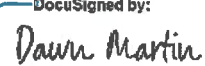
