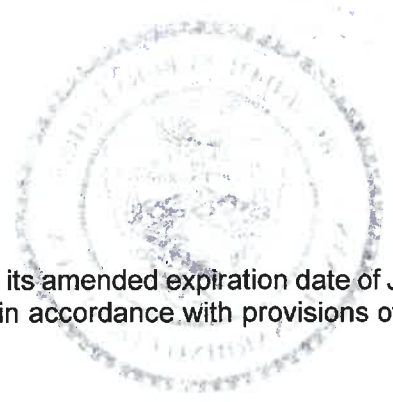
AMENDMENT NO. 2

SECTION VIII. TERM

Amend Section VIII to read as follows:
