The County of San Bernardino Law and Justice Group requests funding to establish Internet connection to courthouses from each jail facility in the County of San Bernardino, including Central Detention Center, Glen Allen Rehabilitation Center, High Desert Detention Center, West Valley Detention Center, and Juvenile Hall, in order to benefit as many people in the County as possible. This will be achieved through improvement to the infrastructure at San Bernardino County detention centers in regards to internet access and bandwidth, and provision of additional dedicated access points to all law and justice partners. Additional audio-video equipment is also needed in the jail and court facilities, and for use by all law and justice partners as well.
