IT IS HEREBY AGREED AS FOLLOWS:

AMENDMENT No. 1

WITNESSETH:

IN THAT CERTAIN: Contract No. 20-948 by and between the County of San Bernardino, now known as San Bernardino County ("County") and Satellite Tracking of People, LLC ("Contractor") for providing Global Positioning System tracking services for adult and juvenile offenders, which first became effective October 1, 2020, the following changes are hereby made and agreed effective January 1, 2022:

I. SECTION D. TERM OF CONTRACT is hereby amended to read as follows:

This Contract is effective as of October 1, 2020 and expires December 31, 2022, but may be terminated earlier in accordance with provisions of this Contract.

II. SECTION F. FISCAL PROVISIONS, Paragraph F.1 is hereby amended to read as follows:

F.1 The maximum amount of payment under this contract shall not exceed \$820,000, and shall be subject to availability of other funds to the County. The consideration to be paid to Contractor, as provided herein, shall be in full payment for all Contractor's services and expenses incurred in the performance hereof, including travel and per diem.

III. Replace all references in the Contract to County from County of San Bernardino to San Bernardino County.

IV. All other terms, conditions, and covenants in Contract No. 20-948 remain in full force and effect.
