IT IS HEREBY AGREED AS FOLLOWS:

AMENDMENT NO. 1:

It is hereby agreed to amend Contract No. 19-305, effective May 20, 2020, as follows:

SECTION II. CONTRACTOR SERVICE RESPONSIBILITIES

Amend Paragraph EE to read as follows:

EE. Not remove a youth without being served with written notice by CFS, fourteen (14) calendar days prior to the change of placement.

Add Paragraph W to read as follows:

W. Collaborate with CFS on the implementation of a placement preservation strategy, pursuant to Assembly Bill (AB) 2247.

SECTION IV. COUNTY RESPONSIBILITIES

Add Paragraph N to read as follows:

N. Prior to making a placement change, develop, implement, and document a placement preservation strategy, in consultation with the Child and Family Team, as specified in AB 2247 unless the youth is in imminent danger, the requirements of AB 2247 have been waived, or if the change of placement is pursuant to court order or for the purpose of placing the youth in an adoptive home.

Add Paragraph O to read as follows:

- O. If after implementing the placement preservation strategy and a change of placement is necessary, serve at least fourteen (14) calendar days written notice, prior to the change, unless the youth is in immediate danger, the requirements of AB 2247 have been waived, or if the change of placement is pursuant to court order or for the purpose of placing the youth in an adoptive home.

SECTION XII. CONCLUSION

Add Paragraph D to read as follows:

- D. This MOU may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same MOU. The parties shall be entitled to sign and transmit an electronic signature of this MOU (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed MOU upon request.

All other terms and conditions of Contract No. 19-305 remain in full force and effect.
